The scheme aims at holistic development of children below 6 years of age and pregnant women & lactating mothers, including of urban poor, by providing a package of services comprising (i) Supplementary nutrition (ii) Pre-school non-formal education (iii) Nutrition and health Education (iv) Immunization (v) Health check-up and (vi) Referral services through Anganwadi Centres at grassroots level.




